WHAT WE COLLECT

We collect all manner of WEEE including:

Servers, Tonners, PCs, Laptops, Projectors, Desktops, Towers, TFT Monitors, CRT Monitors, UPS Systems, Laser Printers, Plotters, Server Racks, Network Switches & Hubs, RAID Arrays, Network Storage, Network Routers & Firewalls, Other Miscellaneous IT Equipment, Telephone systems, any other related WEEE including but not limited to the above.



HOW WE OPERATE

A. OUR PEOPLE:

Our drivers and team who attend to your collections are all fully vetted, secured Staff.

All our staff undergo a full CRB (Criminal Records Bureau) check before they commence any work with Enviro Electronics; be it fleet, warehouse or in any of our offices on the handling of sensitive data (whether that be; hard drives, backup disk tapes, or confidential documents). An individual copy of a staff's CRB record is always carried with them along with a formal ID whilst offsite undertaking collections duties and they will be happy to produce them at your request.

B. OUR PREMISES:

Confidential Destruction Premises



CCTV Systems

Our secure disposal facility includes on-site CCTV systems which monitors the premises on a day-to-day basis, allowing the unloading process of sensitive storage bearing devices to be visually documented on arrival.



Intruder Alarm

An intruder alarm is also visible which sounds and alerts a dedicated 24 hour call centre, who then take the necessary action.

C. OUR PROCESS



1. BOOKING

You can book/request for collections either by calling or via our online portal.

Our trained agents are always on standby to pick up your bookings and advise you of a suitable date for collection. They would then manage all queries and enquiries during the process until you receive all your reports.

2. COLLECTION

We set off from our premises with your choice bin and or cage and all relevant details and documents with the aim of completing your collection between 8am-3pm, irrespective of where you are in the country. The driver will also call, whilst en route.

3. AT YOUR PREMISES

At your premises, our DBS checked drivers will request to meet the named transferor on the WTN (Waste Transfer Note). The driver is then supervised by the transferor until all the collections are completed after which the required WTN and or HTN (Hazardous Transfer Note) are signed by both the driver and the transferor and handled accordingly.

The requested bin/cage is then left.

4. YOUR ASSETS TRANSPORTED SAFELY

Our tracked and secured vehicles will transport your assets safely to our premises before 6pm of the same day of collection.

5. OUR PREMISES

Our premises boasts of state of the art security CCTV systems, 24 hour manned surveillance and intruder alarm systems.

Our data processing /shredding area is inbuilt and under lock and key. It houses an industry standard Nord data shredding machine, stand alone data sanitizers and degaussers. And we also operate a Kill disk industrial licensed for 100 bays amongst other industry approved software.

Currently, industry leading experts recommend firstly wiping or degaussing storage bearing devices such as Hard Drives to a certified precedent such as HMG infosec 5 and PCI DSS and then to physically destroy each device thereafter.

This ensures all data bearing items are cleansed before shredding. Our trained staff will then process your assets in line with industry standards and prepare your reports accordingly.

6. YOUR REPORTS

Within 7 working days from collection, your asset reports and certifications are ready and uploaded to your portal, accessible from our website. This gives you access to infinte downloads and also creates a record and history of all your reports.



Equipment which is 5 years or older invariably tends to be recycled, with precious metals extracted from components such as motherboards, RAM and cabling through a specialized processing plant. These materials are then used to create newer and more desirable products.

YOUR REPORTS & CERTIFICATES

Thereafter completed asset reports are for warded to clients in a **PDF** electronic format and are also available in hard copy. A typical asset report will include the following information as a minimum (although additional information can be added if required).


- Make & model of each item of equipment.

- Complete WEEE certificate containing EWC codes & serial numbers.
